7. Selected candidates for the post of Sr. No .2, 3 & 4 are liable to be posted in any corporation mentioned in the advertisement.

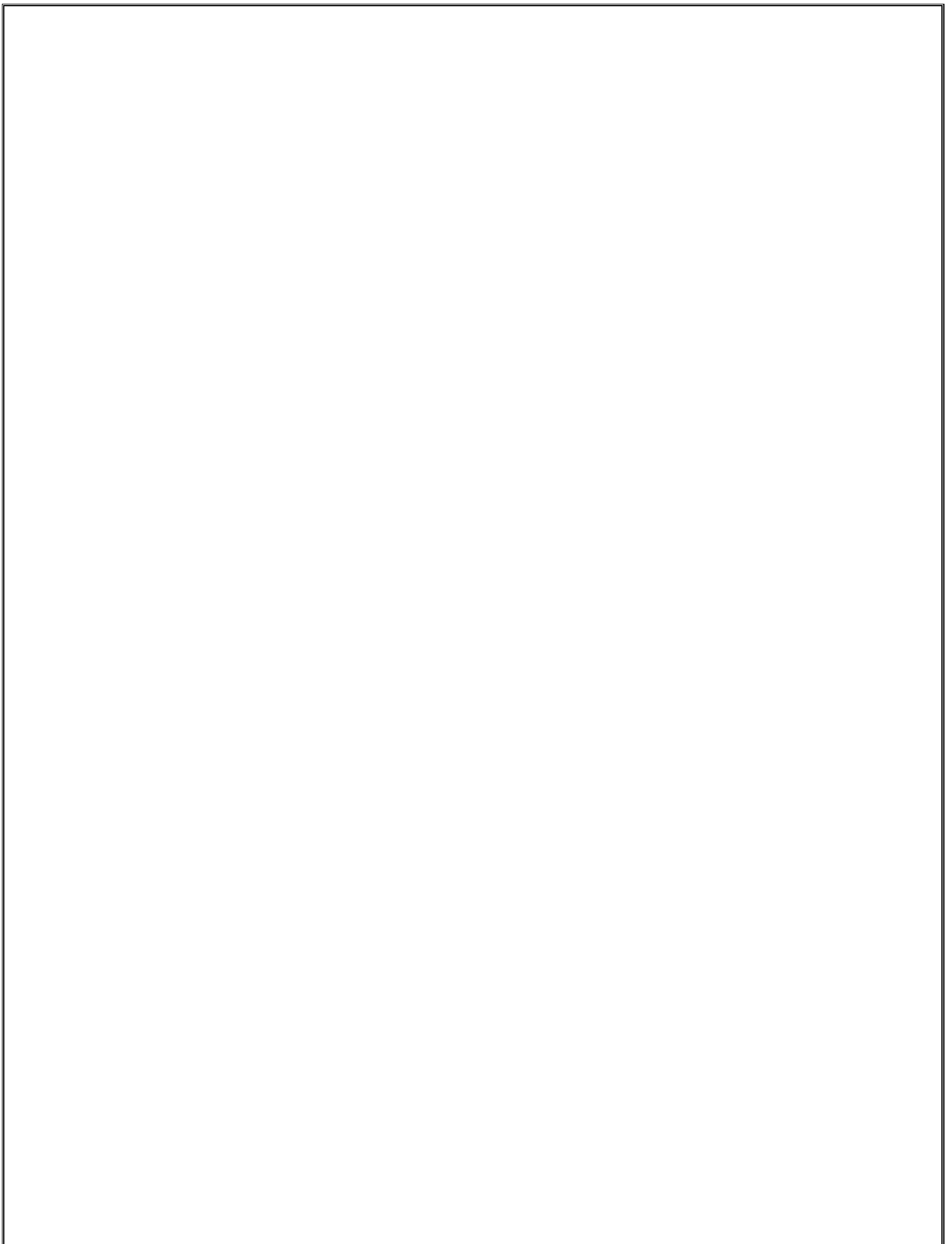
8. The appointment of the selected candidate will be for the period of 11 months, which likely to be extended if performance is satisfactory, subject to continuation of project/ programme. If the project/ programme is not extended; the contract will be terminated without any notice and candidate cannot claim any right on the post or posting or cannot file any litigation regarding employment protection.
9. Age criteria will be relaxed by 5 years for those existing NHM employees, who have served at least three continuous contract period of 11 months each.
10. All required qualifications must be of full time courses from a Government recognized university. Educational qualification from open universities won't be considered.
11. Candidate should possess required minimum educational qualification on the last date of the receipt of applications. Minimum & maximum age will be as on last date of receipt of applications.
12. Experience acquired after passing minimum education qualification required for particular post will only be considered. An experience not relevant to the post will be ignored.
13. The experience will be relaxed if sufficient candidates are not available.
14. For MBBS /PG qualification candidates, service under NHM is considered as bonded service.
15. The candidate is required to fill up and submit Small Family Declaration Form at the time of interview/appointment. In case it is found that the candidate is not fulfilling this norm, his candidature / appointment will be cancelled immediately.
